2019 AGM President's Report

I would like to first and foremost thank everyone for their help and support of the club over the last year. It was a busy year for the board with track improvements, city relation projects, Sask Cup/Grand's and fundraising. Also over the winter we have been hard at work planning for the future of the club.

Last year we successfully got our drainage installed after many years of work with the City of Saskatoon. It greatly improved the tracks ability to shed water and allowed our club to use the facility quickly after a rainfall. It also took some of the pressure off of our volunteers as we no longer had to pump water. We reshaped most of the track and rebuilt the rhythm sections. These were all great improvements to make our facility a better place for our members and community to use.

Over the winter we worked with the City of Saskatoon to finally get our lease agreement in place so we can secure the location of our track for the next 10 years. We are glad to announce that Globe and the city agreed to the terms and it has been passed through city council and approved (as of a few days ago). It still needs to be drafted and signed but the major hurdle has been accomplished.

We successfully hosted the Sask Cup Grand's and Provincial Championships last year and we had a record turn out. It was amazing to see all the kids at the track competing for their P and SK plates. We are thankful for help and support the SCA provided during these events. We also had our first annual summer classic fundraising race. I personally had a great time and loved seeing all of the families out for the event. It was an important focal point as it was our main fundraising event for the year.

Part of our obligation to our members is to ensure the continued success and growth of the club. In the survey that we passed around in 2017, constructing a new track was one of the top subjects. We worked extensively this winter on starting the process on this task. We researched a few different track designers and determined that Tom from TRD is our guy. As we are a partner with the City of Saskatoon we need to be in consultation with them on such a project. We have had many meetings with the COS, Crosby Hanna (landscape designers), and TRD to figure out where and what to build. We love our current spot and determined as a group that Lakewood Park is where we belong. We are very excited to release the prelim track drawings and are going to be looking for future sponsors to tackle this project. Stay tuned for our track development presentation coming up later in the meeting.

Old blue our starting gate had a long and amazing life but we were sad to say it was time for an upgrade. Gate technology has come a long way and the safety of our members is our top priority. With some consolation we decided it would be best to replace the gate with a new

crescent style. We are happy to say the gate is installed and working. Thank you to the many companies, and individuals that helped out and made the project a success.

In closing I am excited for the 2019 racing season, we will be hosting 2 provincial races and the Sask Cup Grand's and Provincials once again. Our Summer Classic is scheduled and I am sure it will be a blast. Thank you fellow board members, Globe Members, SCA and our community for the continued success of Globe BMX
